ENEMIES OF THE APARTHEID STATE

We act for Mr Eric Anthony Abraham.

Our client's name appeared amongst the list of 7 000 opponents of the apartheid regime published in the erstwhile This Day Newspaper in or about 1 December 2003. The latter newspaper stated that files of the people listed in the aforementioned publication were kept by the old Security Legislation Directorate of the Department of Justice and were never made public and are therefore currently held by the National Archives Repository in Pretoria.

We accordingly request on behalf of our client that we be allowed access and or provided with copies of all the contents of our client's file. Our client's file number is 3625. His South African Identity number at the time was 654014203. He obtained an indemnity from prosecution by the Department of Justice in 1991 and his reference number in this regard is 6/2 2702/91 (B6) and (B40). He is now a British Citizen.

3. notice of withdrawal of our client's South African passport;
