3. Since the above letter of 8.7.1976, he has continued his smear campaign against the Republic abroad.

RESTRICTION: Eric Antony ABRAHAM

A.1. A memorandum with regard to the above person's activities together with particulars regarding the justice questionnaire is attached for your information and consideration of group "C" restrictions.

2. ABRAHAM's continued undermining of internal security has now reached a high point with his formation of the Southern African News Agency (SANA) which is aligned on vilifying the Republic abroad, especially with regard to so-called political trails and arrests.

3. Also attached for your information are 2 (two) copies of the January and February/March 1976 editions of SANA which the Publications Directorate considers undesirable and to which reference is made in paragraphs 32 and 36 of the Memorandum.

4. Subject continuously changes his residential address. It is suggested that before restriction orders are issued you first check his latest address with this office.

5. The Office of State Security also feels that Group "C" restrictions are justified and necessary in his case.
